Please be informed that the Board of Directors of Prime Orion Philippines, Inc. (the "Company"), at its regular meeting held this morning, approved the new growth plans and strategies of the Company which will focus on the redevelopment of its prime asset, Tutuban Center, to revive its role as a key retail and commercial hub in the city of Manila. To ensure alignment, the organization, its operations and processes, including manpower complement, will be restructured. The initial phase of the Tutuban Center revitalization is ongoing, with improvements to facilities, such as parking, already completed.

The Board also approved the setting of the Company's 2016 Annual Stockholders' Meeting for 29 November 2016 at 9:00 o'clock in the morning at Makati Sports Club, Makati City. The record date for the determination of stockholders entitled to notice and to vote at the meeting is 17 October 2016.
