Further to our disclosure on 3 November 2015, please be advised that the Securities and Exchange Commission approved yesterday, 4 July 2016, the amendments to the Seventh Article of our Articles of Incorporation to -

- 1. decrease the authorized capital stock of our Corporation from P3,000,000,000 to P2,400,000,000 in view of the retirement of the 600,000,000 convertible preferred shares with par value of P1.00 per share; and
- 2. increase the authorized capital stock of our Corporation from \$\text{P2},400,000,000\$ divided into 2,400,000,000 common shares with par value of \$\text{P1.00}\$ per share to \$\text{P7,500,000,000.00}\$ divided into 7,500,000,000 common shares with par value of \$\text{P1.00}\$ per share. Out of the increase in the said authorized capital stock, Ayala Land, Inc. has subscribed to 2,500,000,000 common shares.
