Please be advised that one of our Independent Directors, Atty. Ricardo J. Romulo, has tendered his resignation that will take effect upon the acceptance thereof by our Board of Directors. His resignation is due to health reasons, and not due to any disagreement on matters between him and our Board or management. He has also withdrawn his acceptance of his nomination for the same post for our Annual Stockholders' Meeting ("ASM") set for 29 November 2016.
