

In compliance with the Disclosure Rules of the Securities and Exchange Commission and the Philippine Stock Exchange, and further to our disclosure on 23 March 2018, please be informed that today, 30 April 2018, Ayala Land, Inc. (ALI) and Prime Orion Philippines, Inc. (POPI) executed a Deed of Exchange whereby POPI acquired from ALI its 75% equity in Laguna Technopark Inc. (LTI) in exchange for additional POPI shares. POPI will issue 1,225,370,620 common shares to ALI in exchange for 30,186 LTI common shares. As a result of the exchange, ALI's direct ownership in POPI will increase from 54.91% to 63,90%.

The effectivity of the exchange shall be subject to and deemed effective upon issuance by the Securities and Exchange Commission (SEC) of the Confirmation of valuation of the shares.

Applications for confirmation of valuation and for a tax-free exchange ruling are expected to be filed with the SEC, and the BIR, respectively, on 30 April 2018.
